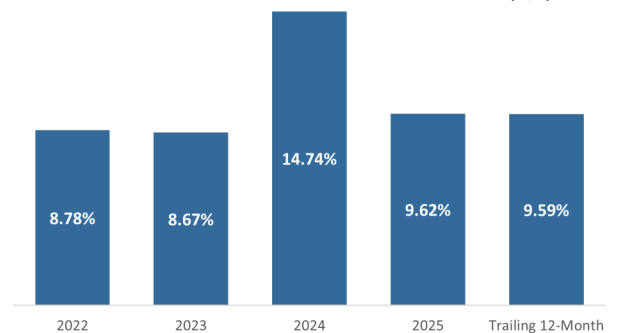

A lower value indicates historically less volatility. 5) Sharpe Ratio evaluates risk-adjusted returns using the 3-Month U.S. Treasury Bill Rate as the risk-free rate. A higher ratio indicated a more attractive risk-return profile. 6) Max drawdown is the maximum loss from a peak to a trough of a portfolio, before a new peak is attained. 7) Distribution rates are not performance and are calculated by summing the quarterly distributions per share over the prior four quarters and dividing by the NAV as of the latest month end. 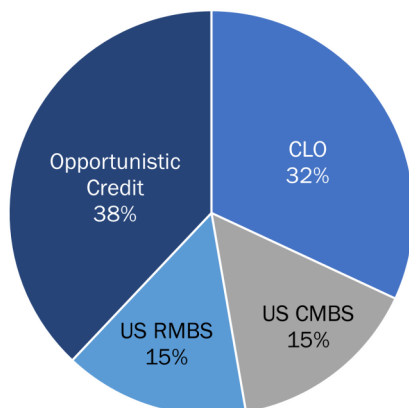

Historical Distribution Rate¹⁰ (01/31/2026)

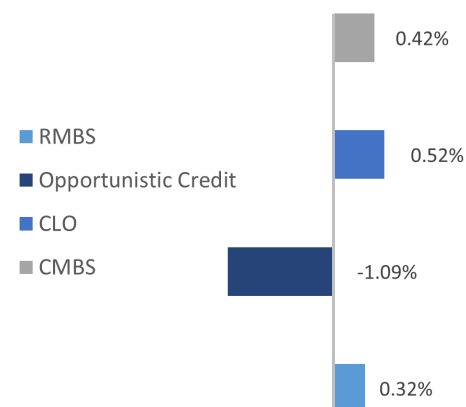


Portfolio Composition (01/31/2026)

Note re: Disclosure of fund fees and expenses / Net 4.91% Gross 6.84%: "Fees and Expenses" is what the fund expects to incur. It includes the following: a management fee, which is paid to the investment manager at an annual rate of 1.85% payable monthly in arrears, accrued daily based upon the fund's average daily net assets. Such management fees are paid before giving effect to any repurchase of shares in the fund effective as of that date and will decrease the net profits or increase the net losses of the fund that are credited to its shareholders. The 4.91% Net Fund Fees & Expenses discussed includes management fee estimated at 1.85%. Fees also include the "Expense Limitation" which includes ordinary operating expenses and other fees before investments, estimated at 0.75%, and a shareholder servicing expense at 0.25% bringing total before investment related fees to 2.85%. It also includes investment related fees of approximately 2.06%. It does not include Fee Waivers and Reimbursements, which are estimated at 1.93% as of the current fiscal year.

Investing in the Fund's shares involves risks, including the following: Shares of the Fund will not be listed on any securities exchange, which makes them inherently illiquid. There is no secondary market for the Fund's shares, and it is not anticipated that a secondary market will develop. The shares of the Fund are not redeemable. Although the Fund currently intends to offer to repurchase 10% of outstanding shares on a quarterly basis in accordance with the Fund's repurchase policy, the Fund is not required to repurchase shares at a shareholder's option nor will shares be exchangeable for units, interests or shares of any security. While the repurchase amount for each offer is currently anticipated to be 10% of outstanding shares, the Fund is not required to, and in the future the Fund may not, extend repurchase offers in excess of 5% of outstanding shares. Regardless of how the Fund performs, an investor may not be able to sell or otherwise liquidate his or her shares whenever such investor would prefer and, except to the extent permitted under the quarterly repurchase offer, will be unable to reduce his or her exposure on any market downturn. If and to the extent that a public trading market ever develops, shares of closed-end investment companies, such as the Fund, may have a tendency to trade frequently at a discount from their NAV per share and initial offering prices.
